

DATA PROTECTION POLICY

English translation, German original text prevails.

About the processing of your personal data in the context of the use of our website we inform you below . "Personal data" is any information relating to an identified or identifiable natural person (e.g. name, address, e-mail address, etc.).

1. RESPONSIBLE PERSON

2. YOUR RIGHTS

You have the following rights with regard to the personal data concerning you:

■ in accordance with Art. 15 DSGVO to request information about your personal data processed by us. In particular, you can request information about the processing purposes, the category of personal data, the categories of recipients to whom your personal data have been or will be disclosed, the planned storage period, the existence of a right to rectification, erasure, restriction of processing or opposition, the existence of a right of complaint, the origin of your data, if it was not collected by us, as well as the existence of automated decision-making, including profiling and, if necessary, meaningful information about its details; in accordance with Art. 16 DSGVO to demand the correction of inaccurate or incomplete personal data stored by us without undue delay; in accordance with Art. 16 DSGVO to demand the correction of inaccurate or incomplete personal data stored by us without undue delay;

- pursuant to Art. 17 DSGVO, to request the erasure of your personal data stored by us, unless the processing is necessary for the exercise of the right to freedom of expression and information, for compliance with a legal obligation, for reasons of public interest, or for the establishment, exercise or defense of legal claims;

3. COLLECTION OF ACCESS DATA AND LOG FILES

When you use our website for information purposes only, i.e. if you do not register or otherwise transmit information to us, we only collect the personal data that your browser transmits to our server. If you wish to view our website, we collect the following data, which is technically necessary for us to display our website to you and to ensure its stability and security. The legal basis is Art. 6 para. 1 p. 1 lit. f DSGVO:

- Language and version of the browser software.

The aforementioned information is stored for security reasons (e.g. for the clarification of abuse or fraud) for a maximum period of 10 days and then deleted. Data whose further storage is necessary for evidentiary purposes is excluded from deletion until the final clarification of the respective incident. In addition to the aforementioned data, cookies are stored in your browser history when you use our website (see section 5 of the privacy policy).

4. SSL OR TLS ENCRYPTION

Our website uses SSL or TLS encryption for reasons of IT security and to protect the transmission of confidential content (e.g. inquiries or account openings). You can recognize an encrypted connection by the fact that the address line of the browser changes from "http://" to "https://" and by the lock symbol in your browser line. If SSL or TLS encryption is activated, data that you transmit to us cannot be read by third parties.

5. USE OF COOKIES

Our website uses so-called "cookies". These are small text files that are stored in your browser history. They are used to make our website more user-friendly and effective overall.

You have the option of blocking the setting of cookies and deleting cookies that have already been set. You can obtain more information on this from the manufacturer or in the help function of your Internet browser. The exclusion of cookies can lead to functional restrictions of our website.

We use the following types of cookies, the scope and functionality of which are explained below:

Functional cookies

The functional cookies ensure that our Internet site functions properly. A storage of these **cookies** the data is stored for a maximum of 2 years, after which it is automatically deleted. For example, the following functions are possible with these cookies:

- as save presets such as language, location, number of search results, etc.,
- saving settings for optimal video display, e.g. the desired buffer size and the resolution data of your screen,
- the collection of your browser settings in order to display our Internet site optimally on your screen,
- the detection of misuse of our websites and services, e.g. through the registration of several successive as well as failed login attempts,
- the steady loading of the web page, so that the web page remains accessible or
- saving your login data so that you don't have to enter it every time.

6. EXTERNAL LINKS

Within our website there are also links to websites of third parties. These are usually identified by the Internet address. We have no content and design of these websites of other providers and therefore cannot extend the content of this data protection declaration to such third-party websites.

7. E-MAIL CONTACT

If you provide us with your e-mail address, we will communicate with you by e-mail. If you no longer wish to receive such information, you can revoke your consent at any time. We would like to point out that communication by unencrypted e-mail is insecure and the confidentiality of the information transmitted cannot be guaranteed. We recommend that you send us confidential information exclusively by encrypted e-mail or by post.

8. NEWSLETTER

With your consent, you can subscribe to our newsletter, which will inform you about our products and services, current market topics, exclusive promotions and competitions, and provide you with valuable tips on Forex and CFD trading.

To register for the newsletter, you must provide your e-mail address. The provision of further, separately marked data is voluntary and will be used to address you personally. After your confirmation, we store your e-mail address for the purpose of sending you the newsletter. The legal basis is Art. 6 para. 1 p. 1 lit. a DSGV0.

For the registration to our newsletter we use the so-called double opt-in procedure. This means that after your registration, we will send you an e-mail to the specified e-mail address, in which we ask you to confirm that you wish to receive the newsletter. In addition, we store your IP addresses and the times of registration and confirmation. The purpose of this procedure is to verify your registration and, if necessary, to be able to clarify a possible misuse of your personal data.

You can revoke your consent to receive the newsletter at any time and unsubscribe. You can revoke your consent by clicking on the link provided in each newsletter e-mail, by sending an e-mail to datenschutz@captrader.com or by sending a message to the contact details provided in section 1 of the privacy policy.

9. MAILCHIMP

We use the "MailChimp" service for the registration, dispatch and analysis of our newsletter. The provider is Rocket Science Group LLC, 675 Ponce De Leon Ave NE, Suite 5000, Atlanta, GA 30308, USA.

The personal data provided by you when registering for the newsletter or subsequently supplemented by you will be stored on the servers of MailChimp in the USA.

With the services of MailChimp, we can analyze our newsletter actions. When you open an e-mail sent with MailChimp, a data file contained in the e-mail (so-called web beacon) connects to the MailChimp servers in the USA. In doing so, we record whether newsletter messages are opened, when they are opened and which links, if any, are clicked on. In addition, technical information is collected (e.g. time of retrieval, IP address, browser type and operating system). For technical reasons, this information can be assigned to individual newsletter recipients. However, it is neither our intention nor, if used, that of the dispatch service provider to observe individual users. The analyses serve us much more to recognize the reading habits of our users and to adapt our content to them or to send different content according to the interests of our users. The analysis is not possible if you have deactivated the display of images by default in your e-mail program. In this case, the newsletter will not be displayed in its entirety and you may not be able to use all of its functions. If you display the images manually, the above-mentioned analysis will take place.

The data processing is based on your consent (Art. 6 para. 1 p. 1 lit. a DSGVO). You can revoke this consent at any time by unsubscribing from the newsletter (see section 9 of the privacy policy). The legality of the data processing operations that have already taken place remains unaffected by the revocation.

The data you provide for the purpose of receiving the newsletter will be stored until you unsubscribe from the newsletter and will be deleted from our servers as well as from the servers of MailChimp after you unsubscribe from the newsletter. Data that has been stored by us for other purposes (e.g. e-mail addresses for the customer area) are not affected by this. 10. CONTACT FORM / LIVE CHAT

The data you enter in the contact form or live chat will remain with us until you request us to delete it, revoke your consent to store it, or the purpose for storing the data no longer applies (e.g. after we have completed processing your request). Mandatory legal provisions such as retention periods remain unaffected.

11. SOCIAL ICONS

So-called social icons (e.g. from Facebook, Twitter, YouTube, Google Plus, LinkedIn, XING, Instagram) are integrated on our website. These are only integrated on our website as a link to the corresponding services. After clicking on the embedded graphic, you will be redirected to the page of the respective provider, i.e. only then will personal data be transferred to the respective provider. 12. AFFILIATE MARKETING

We use affilinet tracking cookies on our website to record sales/ leads. These affilinet tracking cookies do not store any personal data. Only information identifying the referring partner as well as an order number of the advertising material clicked on by the website visitor is recorded. This information is required for payment processing between us and the referring partner. The partner identification serves the allocation and determination of the commission to be paid to the mediating partner upon completion of a transaction. The legal basis is Art. 6 para. 1 p. 1 lit. f DSGVO.

13. YOUTUBE VIDEO INTEGRATION

By visiting the website, YouTube receives the information that you have accessed the corresponding subpage of our website. In addition, the data mentioned in paragraph 3 of the data protection declaration are transmitted. This occurs regardless of whether YouTube provides a user account via which you are logged in or whether no user account exists. If you are logged in to Google, your data will be directly assigned to your account. If you do not want the assignment with your profile at YouTube, you must log out before activating the button. YouTube stores your data as usage profiles and uses them for the purposes of advertising, market research and/or demand-oriented design of its website. Such an evaluation is carried out in particular (even for users who are not logged in) for the provision of tailored advertising and to inform other users of the social network about your activities on our website. You have the right to object to the creation of these user profiles, whereby you must contact YouTube to exercise this right.

If you are logged in to Google, your data will be directly assigned to your account. If you do not want the assignment with your profile at Google, you must log out before activating the button. Google stores your data as usage profiles and uses them for purposes of advertising, market research and/or demand-oriented design of its website. Such an evaluation is carried out in particular (even for users who are not logged in) for the provision of tailored advertising and to inform other users of the social network about your activities on our website.
